Economic Development

High praise for our city continues to stream in as *Newsweek* announced that we're home to two of the best high schools in the nation (Ferris High School and Lewis & Clark High School) and *Forbes* has ranked Spokane as one of the Top Ten Places for Business and Careers.

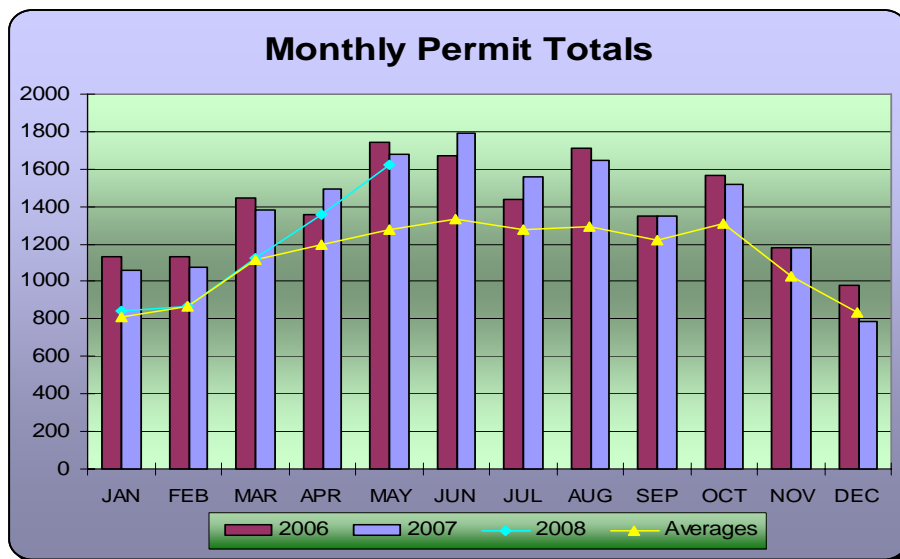
The latter accolade is due in part to our climate of encouraging development within the city limits by maintaining some of the lowest Building Permit fees and the quickest construction approval times in the State. Over the past 12 months, commercial Plan Reviews have only taken an average of:

- 17 days for Tenant Improvements
- 29 days for New Commercial Buildings & Additions

Building Permits

Overall permit activity climbed by more than 200 permits processed for the third straight month leading to over 1,600 permits processed for only the eighth time ever!!



This surge in activity has been split between Commercial Construction and Residential Remodels which continue to be strong as both are on pace to make 2008 the third best year on record for those categories.

WinCo Foods is coming!! The largest project for permits issued in May was for the 101,000 square foot, \$8.2 million [WinCo Foods](#) at 9527 North Nevada Street.

WinCo, which stands for "Winning Company" (*and also forms an acronym for the five states in which it has stores: [Washington](#), [Idaho](#), [Nevada](#), [California](#), and [Oregon](#)*) is an employee owned, 24-hour, low-price supermarket that promises to employ over 100 of our city's finest with competitive wages that "generally exceed community standards" plus stock options with a lucrative annual growth rate of 21.2% that helps foster an "extremely dedicated workforce" with a turnover rate that is "20% below average" according to their [website](#).
